SUMMARY:

The Camino Venture Fund is dedicated to sourcing, creating, and then launching high impact businesses that further God's Kingdom.

High impact businesses have two common traits:

- 1) They reach financial sustainability.
- 2) They have clear, reachable plans to create impact for the Kingdom of God.

FUND MANAGER:

Camino Foundation is a 501(c)3 and asset management subsidiary of Camino Global. The manager specializes in SME's (small to medium enterprises) that generate sustainable Kingdom Impact.

INVESTMENT OBJECTIVE:

To achieve long term impact by holding a diversified portfolio of Kingdom Impact companies that predominantly operate in Spanish speaking regions throughout the world.

TARGET RATE OF RETURN:

Fund seeks to average a 6% annual return to Camino Foundation. While investments will be made in companies that return far more than 6%, our vision is to see our companies transform their spheres of influence. If high capital returns are required, that capability is diminished.

INVESTMENT HIGHLIGHTS:

- Two companies added in 2016
- 67% of companies reached growth goals in 2016
- Total direct impact remained in line with 2015 results highlighted by 8 Salvations
- Indirect impact in 2016 grew substantially driven by the impact of Lumi and Obrerofiel.
